

CHICAGO PARK SCHOOL DISTRICT
2022/2023 1st INTERIM BUDGET NARRATIVE

Presented for your approval are the 2022/2023 Budget Revision Number One and First Period Interim Reports. These reports reflect actual activity for the period of July 1, 2022 through October 31, 2022 and budget projections for the 2022/2023 fiscal year with known assumptions as of November 30, 2022.

Included in your packet is the CDE's official format often referred to as "SACS reports" which stands for the Standardized Account Code Structure. This report contains forms that show data about the financial status as well as other activities of the District that the CDE requires. The following are highlights of the material changes in revenue and expenditures for this report period:

- LCFF revenue (Property Tax Revenue) increased by \$69,886.00 due to the actual amounts coming in higher than the estimated amounts at the beginning of the fiscal year.
- Classified Salaries decreased by \$(21,910.34) due to changes of staff in positions including aides and custodial.

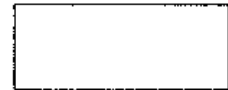
