Dear Chicago Park Family,

Thank you for your interest in enrolling your child in the Chicago Park Elementary School District. To do so, please fill out an Interdistrict Attendance Agreement and return to the school office with this letter.

Due to intensive monitoring by the state of California in the areas of academic success, behavior, and attendance, students that do not meet the criteria listed below may have their inter-district agreements revoked at any time during the school year.

Academic Success – Students in grades 4-8 must maintain a 2.0 GPA to remain in good academic standing. Students in the primary grades must turn in their work on a regular basis. Failure to do so may result in the revocation of the inter-district agreement.

**Behavior** – Any student suspended from school, or who has multiple disciplinary actions, may have their inter-district agreement revoked.

Attendance – It is CRITICAL that your child attends school on a regular basis. Maintaining a 95% attendance rate is very important. We understand children do get ill and will miss school on occasion, but chronic absenteeism may result in a revoked inter-district agreement.

**PROCESS** – Should your child risk falling into the areas as listed above, the school will ask you to attend a meeting to discuss how we can work together to rectify the situation. If the area of concern continues, your child will be returned to their home district.
