

Projected Revenue by Fund Source




This chart shows the total general purpose revenue Chicago Park Elementary School District expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Chicago Park Elementary School District is \$521,513, of which \$369,099 is Local Control Funding Formula (LCFF), \$80,658 is other state funds, \$45,659 is local funds, and \$26,097 is federal funds. Of the \$369,099 in LCFF Funds, \$31,694 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).



In 2024-25, Chicago Park Elementary School District is projecting it will receive \$31,694 based on the enrollment of foster youth, English learner, and low-income students. 

Each of the actions items in goal 1 supports the strengthening academic achievement of all students including special populations which is the focus of goal 1.

Particular success in the 2023-2024 on this goal were in implementing actions 1.6 (Rtl) and 1.11 (Class Size). Having an intervention specialist aide, as well as, a part time teacher was a huge help and resource for the teachers and students. With class size, we found that

getting rid of combination classes allowed teachers to focus more effectively on the specific curriculum and learning objectives for each grade level without the added challenge of accommodating two different sets of standards and student needs. Also, students benefited from instruction that is tailored to their grade level, allowing for more targeted teaching strategies and opportunities for individualized support. Lastly, students in single-grade classrooms often have more opportunities to develop social skills and form relationships with peers who are at a similar developmental stage.

LEA did not struggle to implement any of the action items in goal 1.

All Budgeted Expenditures were incorrect in the 23/24 LCAP. The amounts provided were for the entire organization and included amounts for the District. All actions and estimated expenditures were implemented as planned.

With Action 1.8, the district allocating more hours toward the Sierra Harvest Garden Education program, LEA kept the expanded grade levels (TK-3rd and 6th-8th) served weekly and 4th-5th biweekly in the 2022-2023 school year. Not only does garden education (Agriculture) support science standards, it also supported students in their social and emotional health. According to the March Student Survey, students listed garden education as one of their top three things at Chicago Park School.

Based on our iReady initial assessment vs our mid-year assessment, Actions 1.3 and 1.6, the district saw growth due to the use of iReady for RtI and the support of an RtI aide that would work with students in small groups. Currently, 47% of the whole student body are at grade level or above in ELA and 29% in mathematics. Growth according to iReady, however, was much greater. There has been a 84% average growth in ELA and 58% in mathematics. See below for grade level breakdowns on percent of students with Improved Placement:

After reviewing the data, it is shown that more intervention supports are needed.

The following action item 1.5 (library), 1.6 (Rtl), 1.8 (enrichment), 1.9 (English Language Learner), 1.10 (foster youth support), and 1.11(class size), were effective because we saw an increase in students graduating out of the intervention program and moving to at great level. The following were ineffective 1.1 (Professional Development), 1.3 (iReady), 1.7 (IT Specialist) and have been deleted in the 2024 LCAP.



General Information

Chicago Park School, established in 1898, stands as a beacon of education in the picturesque foothills of the Sierra Nevada Mountains, just off scenic Route 174. Catering to grades TK-8, this small public school boasts a dedicated team of 14 certificated professionals led by the experienced School Superintendent/Principal Katie Kohler, who has held this position since January 2020.

The school's commitment to excellence is evident in its array of programs, including a robust Agriculture program and intensive remedial support for struggling students. Trained Instructional Aides are on hand to provide additional support for low-performing and Special Education students, ensuring that every student receives the attention they need to thrive.

Beyond academics, Chicago Park School offers a diverse range of extracurricular activities, including sports, art, agriculture, music, and computer literacy, along with a variety of after-school enrichment programs. A cornerstone of the school's ethos is its intensive character development program, seamlessly integrated into the daily curriculum, fostering well-rounded individuals.

Serving families primarily from Chicago Park, Grass Valley, Nevada City, Peardale, Colfax, and Alta Sierra, Chicago Park School is committed to providing a positive, safe, and enriching learning environment for all its students.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

In reflecting on our school's annual performance based on a review of the California School Dashboard (Dashboard) and local data, it's evident that while our Suspension Rate is scored in the red (lowest) category at 9.8%, it's important to note that no student groups fall within the red category. This indicates a relatively even distribution of suspension rates across student groups, which suggests a more equitable disciplinary approach in our school.

Similarly, our Chronic Absenteeism rate is at 30.8%, also scored in the red category. However, like with suspension rates, no student groups are in the red. This suggests that while our overall chronic absenteeism rate is concerning, the issue is not disproportionately affecting specific student groups.

These findings indicate that while there are areas for improvement in both suspension rates and chronic absenteeism, our school's approach to discipline and attendance is relatively equitable across student groups. Moving forward, we can use this information to further refine our strategies and interventions to ensure that all students are supported in their academic and personal development.

We emphasize a safe and nurturing environment and graduate responsible students who respect and advocate for the rights of others.

With focusing full efforts into the academic success of students, the students will have a higher success in quality of life and have more opportunities for future successes. Since these are the core values of Chicago Park School, it is critical that the LEA have a goal that is centered around student success.

Based on the CAASPP score, LEA scored below State and County average in ELA, therefore LEA is focusing on intervention and supporting the delivery of mathematics and ELA.

We grouped Priority 1: Basic (Conditions of Learning), Priority 2: State Standards (Conditions of Learning), Priority 4: Pupil Achievement (Pupil Outcomes), Priority 7: Course Access (Conditions of Learning), and Priority 8: Other Pupil Outcomes (Pupil Outcomes) together under the board goal of "Strengthen academic achievement of all students including special populations" because these priorities are interconnected and contribute directly to the overarching goal of improving academic outcomes for all students, including those with special needs.

Priority 1 focuses on the basic conditions of learning, which are foundational to student success. Priority 2 emphasizes the importance of aligning instruction with state standards, ensuring that students are receiving high-quality, standards-based education. Priority 4, Pupil Achievement, directly addresses the outcome of academic success, which is central to our goal. Priority 7, Course Access, is critical for providing all students, including special populations, with equitable opportunities to engage in challenging and rigorous coursework. Finally, Priority 8, Other Pupil Outcomes, encompasses a range of factors that contribute to student success beyond academic achievement, such as social-emotional development and college and career readiness.

 - This percentage is the total of the Planned Percentage of Improved Services column.
- **Planned Percentage to Increase or Improve Services for the coming school year (4 divided by 1, plus 5)**

- This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

Contributing Actions Annual Update Table

Pursuant to EC Section 42238.07(c)(2), if the Total Planned Contributing Expenditures (4) is less than the Estimated Actual LCFF Supplemental and Concentration Grants (6), the LEA is required to calculate the difference between the Total Planned Percentage of Improved Services (5) and the Total Estimated Actual Percentage of Improved Services (7). - **Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)**
 - This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).

LCFF Carryover Table

- **10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 plus Carryover %)**

- This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
 - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**
 - If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.

The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9). This amount is the amount of LCFF funds that is required to be carried over to the coming year.
- **13. LCFF Carryover — Percentage (12 divided by 9)**
 - This percentage is the unmet portion of the Percentage to Increase or Improve Services that the LEA must carry over into the coming LCAP year. The percentage is calculated by dividing the LCFF Carryover (12) by the LCFF Funding (9).
