## Nevada County Indian Education Program

Dear Parent or Guardian,

At the beginning of a new school year, each school district conducts an annual survey to identify American Indian students attending public schools in Nevada County. The form 506, attached to this letter, is a federal form required for Native students to be eligible for Title VI services. The total number of Native students identified determines the amount of federal funding our Indian Education Program will receive each year. Identified Native students are not required to participate in program activities but are eligible for services when needed.

Nevada County Indian Education (NCIE) supports schools in meeting the unique educational and cultural needs of Native students. NCIE provides the following services:

- Individual or group tutoring for all grade levels.
- Native cultural workshops and events.
- Information on local cultural activities and resources.

If your child is of American Indian or Alaska Native descent, please take a few moments to complete this form. Complete a separate form for <u>each</u> child attending public school. If you need additional forms, you may contact your child's school or fill one out directly on our website: <a href="https://nevco.org/indian-education/">https://nevco.org/indian-education/</a> or via the QR code below. Your child <u>does not</u> have to be a registered member of a tribe to participate in our program as enrollment is also based on membership of either parents or grandparents. If you are verified through Chapa-De Indian Health Program, Inc., you may use their name and address as organization maintaining membership data if you don't know that information for you tribe and we can assist you from there. If you do not have verification that your child is Native American, please fill out the form to the best of your knowledge and we may be able to help you get such verification.

When you complete and return this form to your child's school, or submit it online, it will be forwarded to the Indian Education program and kept in a confidential file. Once we verify that the form has all the required information, your child will be enrolled in our program. You <u>do not</u> need to fill out a new form each year unless school or contact information changes.

## ED 506 Form Indian Student Eligibility Certification Form for Title VI Indian Education Formula Grant Program

The grantee receives the grant funds based on the number of eligible forms counted during the established count period. You are not required to complete or submit this form unless you wish for your child(ren) to be included in the Indian student count. This form should be kept on file with the grant applicant and will not need to be completed every year. Where applicable, the information contained in this form may be released with your prior written consent or the prior written consent of an eligible student (aged 18 or over), or if otherwise authorized by law, if doing so would be permissible under the Family Educational Rights and Privacy Act, 20 U.S.C. § 1232g, and any applicable state or local confidentiality requirements.

## **Definitions:**

Indian means an individual who is (1) A member of an Indian Tribe or Band, as membership is defined by the Indian Tribe or Band, including any Tribe or Band terminated since 1940, and any Tribe or Band recognized by the State in which the Tribe or Band resides; (2) A descendant of a parent or grandparent who meets the requirements described in paragraph (1) of this definition; (3) Considered by the Secretary of the Interior to be an Indian for any purpose; (4) An Eskimo, Aleut, or other Alaska Native; or (5) A member of an organized Indian group that received a grant under the Indian Education Act of 1988 as it was in effect on October 19, 1994.

**Student Information:** Write the name of the child, date of birth, grade level, name of school and school district. Only name one child per form.

**Tribal Membership:** Write the name of the individual with the tribal membership, if it is not the child listed. Only one name is needed for this section, even though multiple persons may have tribal membership. Select only one identifier: the child, child's parent or grandparent, for whom you can provide membership information.

Write the name and address of the organization that maintains updated and accurate membership data for such Tribe or Band of Indians. The name does not need to be the official name as it appears exactly on the Department of Interior's list of federally recognized Tribes, but the name must be recognizable and be of sufficient detail to permit verification of the eligibility of the Tribe. Check only one box indicated whether it is a Federally Recognized, State Recognized, Terminated Tribe or Organized Indian Group. Write the enrollment number establishing the membership for the child, parent or grandparent, if readily available, or other evidence of membership.

Attestation Statement: Provide the printed name of parent/guardian and signature, address, phone number and email of the parent or guardian of the child. The signature of the parent or guardian of the child verifies the accuracy of the information supplied.

Paperwork Burden Statement: According to the Paperwork Reduction Act of 1995, no persons are required to respond to a collection of information unless such collection displays a valid OMB control number.
